**RE:** EXTRAMURAL SUPPORT INCENTIVE AWARDS - FY2021:

INFORMATION FOR DISTRIBUTION TO YOUR AAUP-BHSNJ FACULTY AND LIBRARIANS

Extramural Support Incentive Awards will be processed for FY2021 in accordance with the July 1, 2018 – July 31, 2022 collective negotiations agreement between Rutgers and AAUP-BHSNJ (Agreement). The awards will apply to all awards and proposals, including non-competing continuations and new or existing research proposals for projects whose funding continues beyond fiscal year 2019. As you are aware, the extramural support incentives have been modified and expanded significantly in this new agreement. Please carefully review the new incentives. Negotiations-unit members who are required to support a percentage of their salaries using outside grant funds as a condition of employment (e.g., coterminous faculty) shall not be eligible for awards under this program. In addition, faculty on the Professional Practice track will not be eligible for awards under this program. Librarians in the negotiations unit are eligible for their own award program if they are both a principal investigator and the principal author of an externally-funded program which provides support for their salary.

Please distribute notice of this program to your eligible faculty or librarians. In order to confirm eligibility for the award for FY2021 and to initiate payment, an eligible faculty or librarian must complete the appropriate form, including obtaining the required signatures, and submit it to the business manager of the School/Unit. A completed and signed form must be submitted to the School/Unit's business manager by **July 31, 2021**, in order to receive an award for FY2021 in September 2021.
